Annual Topic — Digital Intelligence Transformation Leads the **Future and Gains Momentum** to Core Competitiveness

At present, digital intelligence has become a strong support for enterprise transformation and upgrading. Under the overall guidance of strategic planning, the Group actively plans and promotes the top-level design of digital intelligence transformation with four core values and eight functional areas as its connotation, formulates a strategic blueprint for digital intelligence transformation, continues to enrich digital intelligence application scenarios, and deeply explores the huge potential of digital intelligence technology, and supports the construction of long-term organizational capabilities with digital intelligence, helping to build core competitiveness and promote high-guality development.



In order to improve corporate innovation capabilities and operational efficiency, the Group has increased its efforts to promote the construction of digital and intelligent transformation management systems, to promote digital and intelligent upgrades of production and operations, to promote innovative applications of digital and intelligent technologies, and to continuously activate the potential of data elements in order to help the headquarters build value and Digital intelligence empowerment of industry groups.

Deepen the system construction of digital and intelligent transformation, and promote the close integration of digital and intelligent transformation with key tasks such as the company's strategic management, operation management, and cadre capability improvement from a mechanism perspective.

Add a digital center data department to accelerate data asset management and data resource development from the organizational mechanism.

Organize training and exchanges related to digital and intelligent transformation activities for middle and senior-level cadres across the Group, and invite digital and intelligent transformation experts to to share their experiences, with a view to enhancing the awareness and capabilities of digital and intelligent transformation among middle and seniorlevel cadres.

• C&D Inc. further promoted the construction and operation of online business platforms such as " C&D Cloud Steel", " Zhiyuan Network", " "Jiangyi Tong " and "Agricultural E-point", and promoted the transformation and upgrading of traditional industries. The total transaction amount for the year exceeded RMB 150 billion. Among them, the "C&D Cloud Steel " platform helps steel mills adjust their production plans in real time by connecting with the system data of multiple steel mills, and flexibly allocates upstream raw material procurement and downstream shipment specifications and quantities to help the industrial chain achieve accurate procurement and production planning; The " Zhiyuan Network" and " Jiangyi Tong " platforms cooperate with Tencent to build an Internet ecosystem for the pulp and paper industry, and define various ecological roles from a strategic perspective. Including pilot (C&D Pulp and Paper), escort (Tencent), escort (logistics service partner), battery life (financial service partner) and navigation aid (government, industry associations, universities and research consulting institutions), etc., to achieve synergy, to integrate value-added, and contribute to consolidating the digital and intelligent infrastructure of my country's pulp and paper industry Internet system.

C&D Inc. has also improved the quality and efficiency of supervision of various types of risks through digital means, and created an "E-phase" futures management platform and a real-time shipping monitoring system. These system platforms not only improve the timeliness of risk supervision, but also improve supervision efficiency and effectiveness.

Digital and intelligent upgrade of production and operation



At the 6th Digital China Summit held in 2023. the State-owned Assets Supervision and Administration Commission of the State Council announced the list of winners of the first State-owned Enterprise Digital Scenario Innovation Professional Competition. The "C&D Cloud Steel" platform of C&D Inc.'s Steel Group won the second prize for its digital application scenarios.

O C&D Urban Services draws a " map" of digital and intelligent management and maintenance in urban public facilities management and maintenance services, dynamically presenting the basic information and geographical information of the assets, dynamically updating management and maintenance information, and linking event management, evaluation, negative list registration and other functions to achieve precise positioning and rapid processing, and to fully improve the efficiency and effectiveness of management and maintenance work.

- O C&D Healthcare comprehensively applies new technologies such as big data and artificial intelligence, strengthens the monitoring and control of illegal use of medical insurance, the management of medical insurance disease expenses, etc., and cooperates with Xiamen Medical Insurance Center to realize a series of services such as full-process coverage of medical insurance electronic certificates, mobile settlement of outpatient and emergency/hospitalization expenses and online collection and refund, which greatly improves patients' medical experience.
- C&D INNOSTIC independently developed the "Medical Supply, processing, and distribution (SPD) Management System", which integrates functions such as supplier management, supplier qualification management, product management, product qualification management and supply relationship management. The system realizes the gualification verification and control of the whole process of medical device circulation.

• C&D Real Estate C&D Zhaohui Internet Technology Limited independently designs and builds a smart project management platform, using artificial intelligence, Internet of Things, big data and other technologies, and through the combination of Internet of Things and Internet, it realizes the unified management and operation of multi-party systems and data in project construction, so as to improve the efficiency and convenience of project management and to promote refined and intelligent management.

The platform helps government departments reduce regulatory costs and improve regulatory efficiency, help construction enterprises grasp the construction progress in real time, schedule resources reasonably, and save management costs, and help the construction unit reduce the probability of potential safety hazard accidents and ensure the progress and quality of the project. At the same time, C&D Zhaohui Internet Technology Limited also continues to promote the application of smart equipment such as measuring robots and construction robots in construction sites, as well as the application of various robots such as cleaning, distribution and garbage recycling in property service communities, empowering smart construction and smart property development with technology.

Based on data application scenarios, the Group carried out data asset sorting and data governance in supply chain and other fields, and continuously expanded data applications to deeply explore the value of data.

Adhering to the Leadership of Party Building





Give full play to the leadership role of the party committee in "setting the direction, managing the overall situation, and ensuring implementation", the core role of the board of directors in "setting strategies, making decisions, and preventing risks", and the main role of the managers in "planning operations, implementing, and strengthening management" to enhance modern governance capabilities.

Adhering to Compliance Operations

The Group has always adhered to laws and regulations to govern the enterprise, continuously improved the compliance management system, made every effort to prevent operational risks, improve management energy efficiency, and provide guarantee for the stable development of the Group.

In 2023, the Group established a leading group for the construction of a compliance system to form a compliance management framework system through current situation surveys, risk portraits, sorting out regulatory requirements, industry benchmarking, management logic and overall idea design, etc., and improve the level and quality of corporate compliance management.

In addition, the Group continuously strengthens the awareness of compliance management and promotes the construction of compliance culture through annual legal exchange meetings and special compliance training.

Strengthening Risk Management

Focusing on "magnifying advantages and narrowing shortcomings", The Group continues to lay a solid foundation and continue to improve the comprehensive risk management system, internal control system, and safety production management system that match the company's development goals to protect the high-quality development of the enterprise.

Strengthening Audit Supervision

Focusing on the main responsibilities and main businesses. The Group continued to strengthen audit supervision. deepened the construction of internal control and risk management, improved the internal audit management system under the leadership of the Board of Directors, and built a two-level audit system of the Group's headquarters and industry groups.

In 2023, the Group continues to promote the informatization and digitalization of internal audit, and to promote the construction of the Group's audit system to improve audit efficiency, to strengthen risk prevention and control, and to optimize management decision-making.

Safety Production Management

The Group adheres to the safety production management policy of "safety first, prevention first, comprehensive management", conscientiously implements the relevant regulations of "Party and government joint responsibilities, dual responsibility for each position", refines and implements safety production responsibilities, and continuously optimizes the Group's safety production management system.

In 2023, the Group conscientiously implemented the "2023 Special Investigation and Rectification Action for Major Accident Hazards" and other work requirements of the State Council Safety Committee, compiled the "Compilation of Standards for Determining Major Accident Hazards", organized and convened meetings to prevent and contain major production safety accidents, and effectively consolidated all levels of responsibilities, ensure the implementation of special actions, and strive to improve the overall safety quality of the group. In 2023, approximately 20,000 letters of responsibility for production safety were signed at all levels of the Group, more than 2,700 safety emergency drills were held, and nearly 1,500 emergency plans were revised.

In 2023, the Group continued to upgrade the system functions and data analysis capabilities of the comprehensive safety production management platform, using emerging technological means to empower safety production management. This year, the platform expanded its coverage to approximately 400 project sites across the country, serving more than 2,300 safety production management personnel at all levels, essentially achieving the online management of safety production work.

Network Security Management

The Group has established an overall network security management framework of "one center + three-fold guarantee system", and set the goal of "zero major network security incidents throughout the year" to thoroughly implement the network security management responsibilities.

During the 2023, the Group strengthened network asset security, penetration testing, emergency response, offensive and defensive drills, hidden danger management and other measures to ensure business information security in an all-round way.

The Group signs confidentiality agreements with employees to protect customer privacy, business secrets, national authority Deepening reform and innovation Guided by the " benchmarking of worldclass value creation actions", the Group adheres to innovation-driven efforts, continues to deepen reform, continuously stimulates corporate development vitality, and continuously improves corporate core competitiveness and market adaptability.

At the same time. The Group continues to strengthen network security training and publicity to enhance employees' awareness of prevention and ensure information security. In 2023, the Group provided a total of 50 penetration tests for various industry groups, organized 30 special network security emergency drills, had more than 110 employees of professional posts participated in network security skills training, and had more than 15,000 employees at all levels of the company participated in network security publicity and training.



▼ C&D Inc. LIFT Supply Chain Service System




Integration Into the"Dual Circulation"Development Pattern

Building a Balanced Training System


Establishing a Diversified Training System




Environmentally friendly material

Case

Producing paper with bamboo instead of wood helps promote the green development of the pulp and paper industry.

C&D Inc. has innovatively produced its own brand "Qushe" natural bamboo pulp paper. In terms of raw material collection, "Qushe" natural bamboo pulp paper comes from the bamboo forests in Muchuan County, where the local Sinocalamus affinis fiber is suitable for paper making and is a typical clumping plant. It takes three years for the bamboo to mature, and after maturing, it can be harvested annually by cutting the old bamboo and leaving the new ones. Reasonable harvesting can promote the bamboo forest's healthy growth, and the mountains will always be lush and green, thus preventing soil erosion and water loss.



"Qushe" Natural Bamboo Pulp Paper Factory

In terms of environmental technology application, the pulping production line of "Qushe" bamboo pulp paper uses the DDS low-energy super replacement cooking and closed screening technology, which are internationally advanced technologies. The deep delignification of bamboo material and related cleaning technologies have been listed as a major project for the development of major industrial technologies by the National Development and Reform Commission. Compared with wood pulp paper production, every ton of bamboo pulp paper saves one ton of steam consumption. "Qushe" bamboo pulp paper has an energy consumption of about 300 kilograms of standard coal per ton of products, which is about 350 kilograms lower than the national clean standard (650 kilograms of standard coal). In addition, the waste residue from bamboo pulp processing is treated as fertilizer for mushroom cultivation, which can promote local economic development and protect the local ecology.



Renovation of Natural Coastline in Huli District and Xiang'an District of Xiamen City

Carry out marine garbage cleaning activities and use "coastal patrol drones" to accurately identify and locate the quantity and distribution of drifting garbage in the sea, and promote the quality and efficiency of coastline ecological environment management.

A total of approximately 2,500 tons of marine garbage were cleared, and the average distribution density of marine garbage in Xiang'an District decreased by 92.6% compared with that when it first took over in 2021.

Renovation of marine outfall in Huli District, Xiamen City

Carry out drainage pipeline rectification work such as completion of rainwater and sewage pipes, repair of pipeline defects, renovation of rainwater and sewage diversion, and renovation of outdoor rainwater and sewage mixed connection.

A total of more than 20 projects related to the improvement of marine outfall have been carried out, involving nearly 300 drainage units and 270 kilometers of new and renovated rainwater and sewage pipes.

C&D Group actively responds to the "Healthy China" strategy, supports the development of healthcare undertakings, promotes the prosperity of cultural and sports undertakings, promotes the deep integration of national health and national fitness, and continues to demonstrate new achievements in improving people's livelihood and well-being.

Supporting the Development of Healthcare Undertakings,

C&D Group actively innovated and explored ways to support local livelihoods by initiating the establishment of a charitable fund to establish a tertiary comprehensive hospital - Xiamen Humanity Hospital helping Xiamen accelerate the construction of a high-level healthy city.

Since its opening in September 2018, Xiamen Humanity Hospital has strived to provide services to patients with highlevel hardware, superb medical technology and high-quality medical services, and has opened 48 clinical medical technology departments. In 2023, Xiamen Humanity Hospital had an annual outpatient and emergency volume of 772,700 visits and 29,800 discharges.

Xiamen Humanity Hospital is the group's largest social welfare project. As of the end of 2023, the company's cumulative donation investment has exceeded RMB 2 billion.


Targeted Poverty Alleviation Assistance



Rating Report of 2023 Sustainability Report of Xiamen C&D Corp., Ltd

Entrusted by Xiamen C&D Corp., Ltd., the Chinese Expert Committee on CSR Report Rating selected experts to form a rating team to rate 2023 Sustainability Report of Xiamen C&D Corp., Ltd. (hereinafter referred to as "the Report").

I. Rating Criteria

Guidelines on Corporate Social Responsibility Reporting for Chinese Enterprises (CASS-CSR 4.0) of the Chinese Academy of Social Sciences and China Corporate Social Responsibility Report Rating Standards (2020) of "Corporate Social Responsibility Report Rating Expert Committee of Chinese Enterprises".

II. Rating Process
